 - Inventory
 - a. **Net Sales:** report at Income Statement;
 $\text{Net Sales} = \text{Sales Revenue} - (\text{Sales returns} + \text{allowances})$
 $\text{Net Sales} = \text{Sales Revenue} - \text{Sales Discount}$
 - b. **Gross Profit (Gross Margin)**
 $\text{Gross profit} = \text{Net Sales} - \text{COGS (Cost of goods sold)}$
 - Inventory Accounting Systems
 - a. **Periodic**
COGS determined at the end of the period by physical count;
Adjusting Entries at the end of period.

 - ❖ Assuming you sold all your purchases

 - ❖ Correction journal entry

Inventory	xx (Ending Inventory)
COGS	xx (Ending Inventory)
 - *Only have one journal entry for every sale.
 $\text{COGS} = \text{Beginning Inventory} + \text{Purchases} - \text{Ending Inventory}$
* (We refer to Net Purchases)
 $\text{Net Purchases} = (\text{Gross}) \text{Purchases} - (\text{Purchase returns} + \text{allowance})$
 $= (\text{Gross}) \text{Purchases} - \text{Purchase discount}$
 $= (\text{Gross}) \text{Purchases} + \text{Freight-in}$
*The shipping cost that the purchaser has to pay;
Freight-out will not be included because it's paid by sellers.
 - b. **Perpetual**
Inventory and COGS are updated after every sale.
 - Inventory Costs
Include all costs to get inventory to salable condition.
Example: Advertising cost would **not be included** in Inventory Costs because you can sell your inventory without advertising it.
 - Inventory Costing Methods (Inventory Cost Flow Assumption)
 - 1. **Specific Identification**
It requires a detailed physical count, so that the company knows exactly how many of each good brought on specific dates remained at year-end inventory.
