Would she be able to obtain drug coverage if she enrolled in the SNP? - ANSWER - a. Yes. All SNPs are required to provide Part D coverage for prescription drugs.  
b. Yes, but only if she qualifies for Part D prescription drug coverage under her state Medicaid program.  
c. No. Medicare beneficiaries who enroll in an SNP must always obtain their drug coverage through a stand-alone Part D Medicare prescription drug plan that they sign up for independent of their enrollment in the SNP.  
d. Maybe. Some SNPs offer Part D coverage for prescription drugs and some do not.
