**AGGRESSIVE BEHAVIOR RISK ASSESSMENT TOOLS** ARE ESSENTIAL INSTRUMENTS USED IN VARIOUS SETTINGS, INCLUDING HEALTHCARE, EDUCATION, AND LAW ENFORCEMENT, TO EVALUATE THE LIKELIHOOD OF AGGRESSIVE ACTIONS BY INDIVIDUALS. - **STATIC-99:** PRIMARILY USED FOR ASSESSING SEXUAL OFFENDERS, IT ALSO INCLUDES CONSIDERATIONS FOR AGGRESSIVE

BEHAVIOR.

- BRIEF RISK ASSESSMENT FOR ADULTS (BRACE): A QUICK TOOL FOR ASSESSING RISK IN VARIOUS SETTINGS, INCLUDING MENTAL HEALTH FACILITIES.

## APPLICATION OF AGGRESSIVE BEHAVIOR RISK ASSESSMENT TOOLS
