Opportunity in America, however, is not so straightforward. For Hughes's "American," they were, and still are, representative of a class of Americans stuck at the bottom of society by a steadfast goal to steal opportunity from people looked at as an obstacle to the capitalist dream. Opportunity for most Americans, contrary to the "rags to riches" selling point of the American dream, is not an uninterrupted path toward economic mobility. Often, the path of opportunity is a path for the rich only, nonexistent for the Americans who can not buy into opportunity.
