Contracts and Written Notifications

Nine Minimum Elements of a Written Contract

According to A.R.S. § 32-1158(A), construction contracts must include the following nine items:

- · Contractor's name, address, and license number.
- . Owner's name, owner's mailing address, and the address or legal description for the job site.
- · Date contract begins .
- . Estimated date of completion.
- · Description of the work to be performed.
- · Total dollar amount to be paid, including all applicable taxes.
- . Dollar amount of any advanced deposit that has been paid or is scheduled to be paid.
- . Dollar amount of any progress payments and stages of construction when they will be due.
- · Notice of the property owner's right to file a written compliant to the Registrar of Contractors.

Notice of Owner's Right to File a Complaint

The notice of a property owners' right to file a written complaint to the Registrar of Contractors for any violation of A.R.S. § 32-1154 must include the following information in at least 10-point, bold font:

- · Registrar's telephone number and website
- Time period for filing a complaint under A.R.S. 32-1162(A).

Contractor's Duty to Provide Signed Contracts and Written Receipts

According to A.R.S. § 32-1158(B), contractors are required to:

- · Provide legible copies of signed contracts.
- · Provide signed receipts for any cash payments.

Change Orders Must be Signed

- . Any changes to the terms of a construction contract must be in writing and signed.
- . The contractor has a duty to provide legible copies to everyone who signed the changes.

Proof of License Required to Sue for Payment

As noted in A.R.S. § 32-1153, unlicensed contractors cannot sue for payment for construction-related expenses. For a construction contract to be valid and enforceable in a court of law, the contractor must show proof they were duly licensed on (1) the date the contract was entered into and (2) the date of the alleged cause for action.
