AVMA MODEL VETERINARY PRACTICE ACT IS A CRITICAL FRAMEWORK DESIGNED TO GUIDE STATE LEGISLATURES IN THE ESTABLISHMENT AND REGULATION OF VETERINARY PRACTICES ACROSS THE UNITED STATES. THE AMERICAN VETERINARY MEDICAL ASSOCIATION (AVMA) DEVELOPED THIS MODEL ACT TO ENSURE THAT VETERINARY PRACTICE IS CONDUCTED IN A MANNER THAT PROTECTS PUBLIC HEALTH, ANIMAL WELFARE, AND THE INTEGRITY OF THE VETERINARY PROFESSION. PURPOSE OF THE AVMA MODEL VETERINARY PRACTICE ACT

KEY COMPONENTS OF THE AVMA MODEL VETERINARY PRACTICE ACT

- COLLABORATION WITH PUBLIC HEALTH AGENCIES: ENCOURAGEMENT FOR VETERINARIANS TO WORK WITH PUBLIC HEALTH OFFICIALS TO ADDRESS HEALTH CONCERNS AFFECTING COMMUNITIES.
