Attorneys Fees

Attorneys fees have to be reasonable and cannot be excessive. When determining if a fee is reasonable, there are a few factors to consider: (1) what is the customary fee in the community for similar work; (2) the time and amount of work involved; and (3) the experience and ability of that lawyer for that type of work. Generally, a court will not award attorneys fees unless allowed by statute, agreed by contract, or the court is ordering sanctions.

An attorney cannot receive a fee from a third party that is not a client unless: (1) the client gives consent; (2) there's no interference with the attorney-client relationship; and (3) the attorney's confidentiality is maintained.

Contingency Fees

Contingency fees are not allowed in criminal law or family law. A contingency fee must be in writing, and it must include the method of calculation including for settlement, end of trial, and appeal. It cannot be excessive, below 40%. It must also include what expenses are taken out and when they are taken out. Before the client signs a contingency fee agreement, they must be given a statement of rights and the client has three days to retract the agreement.

Referral Fee

A referral fee in return for merely recommending another lawyer violates the Florida Rules of Professional Conduct. Referral fees are generally only allowed in certain circumstances. If the amount divided is proportionate to the work involved, it is allowed. If there is a written agreement with the client for joint representation, and it lays out how the fees are divided, then the referral fee is allowed. However, sharing fees with nonlawyers is not allowed.

Clients Property

All client's property must be kept separate from all attorneys or firm property; no commingling. It must be kept in a separate trust account that is labeled trust account. The lawyer cannot give financial help to the client except for advancing court costs and expenses.

Commingling Funds

All client's property must be kept separate from all attorneys or the firm's property. It must be kept in a separate trust account that is labeled trust account.

Conflict of Interest

A lawyer may not represent a client if doing so would be directly adverse to another client; or if the lawyer's independent judgment would be materially limited by his responsibility to another
