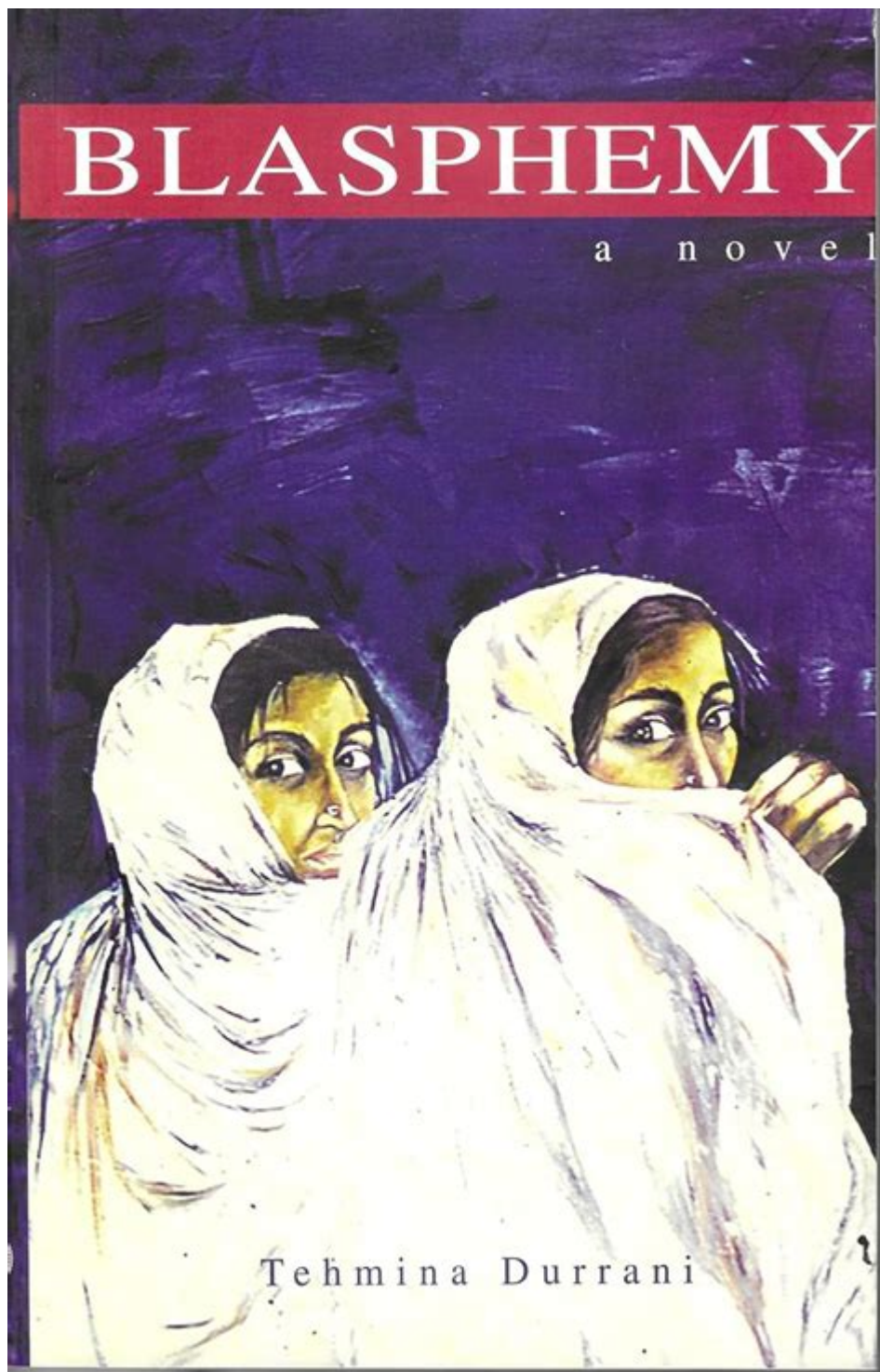


Blasphemy Tehmina Durrani

UNDERSTANDING BLASPHEMY IN SOUTH ASIA

DURRANI GAINED PROMINENCE AFTER PUBLISHING HER MEMOIR, *MY FEUDAL LORD*, WHICH DETAILED HER ABUSIVE MARRIAGE AND THE SYSTEMIC OPPRESSION FACED BY WOMEN IN PAKISTAN.

- CRITIQUE OF PATRIARCHY: THE BOOK HIGHLIGHTED THE PATRIARCHAL STRUCTURES THAT ALLOW FOR DOMESTIC ABUSE AND SOCIAL INJUSTICE.
- PUBLIC BACKLASH: DURRANI FACED SIGNIFICANT BACKLASH FOR HER REVELATIONS, INCLUDING THREATS AND ATTEMPTS TO SILENCE HER.

BLASPHEMY AND ITS CONNECTION TO DURRANI'S ADVOCACY
