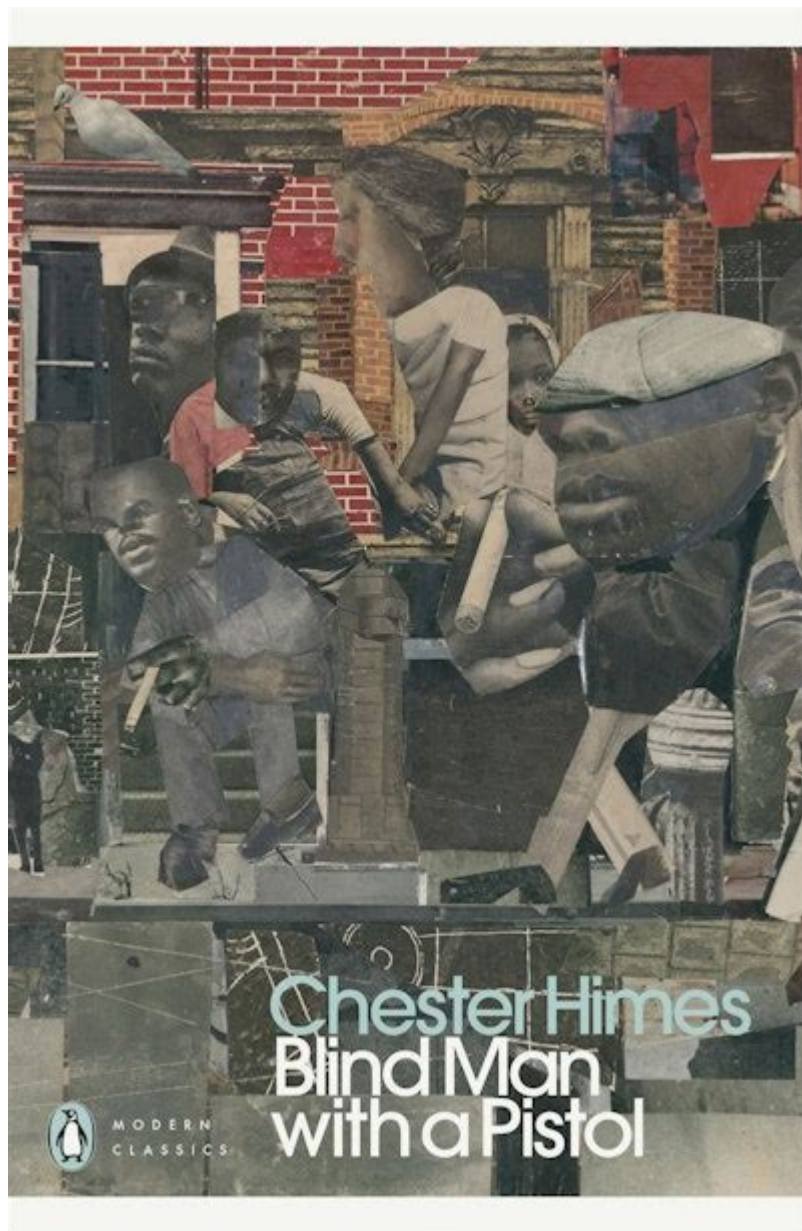


Blind Man With A Pistol



BLIND MAN WITH A PISTOL—A PHRASE THAT EVOKES A MYRIAD OF REACTIONS, RANGING FROM DISBELIEF TO FEAR. LEGAL FRAMEWORK SURROUNDING FIREARM OWNERSHIP

1. SAFETY ISSUES:
