BRIEF ASSESSMENT REFERS TO A CONCISE EVALUATION OF A PARTICULAR SITUATION, INDIVIDUAL, OR PROCESS. THIS METHOD IS UTILIZED ACROSS VARIOUS FIELDS, INCLUDING EDUCATION, HEALTHCARE, AND BUSINESS, TO PROVIDE INSIGHTS, IDENTIFY STRENGTHS AND WEAKNESSES, AND INFORM DECISION-MAKING. 2. FOCUSED: TARGETS SPECIFIC ASPECTS OF THE SUBJECT MATTER.
3. STRUCTURED: UTILIZES STANDARDIZED TOOLS OR METHODS TO ENSURE CONSISTENCY.
