THE PT TESTS A CANDIDATE'S ABILITY TO APPLY LEGAL KNOWLEDGE IN REAL-WORLD SITUATIONS.

KEY DATES FOR THE 2024 EXAM

3. APPLICATION FEES: CANDIDATES SHOULD BE PREPARED TO PAY THE REQUIRED APPLICATION FEES, WHICH VARY DEPENDING ON THE TIMING OF THE APPLICATION SUBMISSION.

PREPARATION STRATEGIES
