4. ADMINISTRATIVE CODE CITATION

- FORMAT: CAL. ADMIN. CODE, TITLE NUMBER, SECTION NUMBER (YEAR).
- EXAMPLE: CAL. ADMIN. CODE, TIT. 8, § 320 (2019).

5. COURT RULE CITATION

- FORMAT: CAL. RULES OF COURT, RULE NUMBER (YEAR).
- EXAMPLE: CAL. RULES OF COURT, RULE 1.10 (2022).

6. SECONDARY SOURCES CITATION

- FORMAT: AUTHOR, TITLE, PAGE NUMBER (YEAR).
- EXAMPLE: JOHN DOE, CALIFORNIA LEGAL WRITING, 45 (2021).

COMMON ABBREVIATIONS IN LEGAL CITATIONS

ABBREVIATIONS ARE WIDELY USED IN LEGAL CITATIONS TO SAVE SPACE AND MAINTAIN CLARITY. HERE ARE SOME COMMON ABBREVIATIONS THAT YOU WILL ENCOUNTER:

- CAL. = CALIFORNIA
- APP. = APPELLATE
- U.S. = UNITED STATES
- REV. = REVISED
- CIV. = CIVIL
- CRIM. = CRIMINAL
- § = SECTION

PUNCTUATION GUIDELINES FOR LEGAL CITATIONS
