DRIVING WITH AN AUTOMATIC LICENSE

AN AUTOMATIC LICENSE TYPICALLY MEANS THAT THE DRIVER HAS PASSED THEIR DRIVING TEST USING AN AUTOMATIC VEHICLE. WHILE THIS LICENSE ALLOWS YOU TO DRIVE AN AUTOMATIC TRANSMISSION VEHICLE FREELY, IT DOES IMPOSE SOME LIMITATIONS WHEN IT COMES TO MANUAL TRANSMISSION VEHICLES.

- RESTRICTIONS: IF YOU HOLD AN AUTOMATIC-ONLY LICENSE, YOU ARE NOT LEGALLY PERMITTED TO OPERATE A MANUAL TRANSMISSION VEHICLE UNLESS YOU HAVE TAKEN AND PASSED A DRIVING TEST IN A MANUAL VEHICLE.

CAN YOU DRIVE MANUAL WITH AN AUTOMATIC LICENSE?

THE SHORT ANSWER IS NO, YOU CANNOT LEGALLY DRIVE A MANUAL TRANSMISSION VEHICLE WITH AN AUTOMATIC-ONLY LICENSE IN CALIFORNIA. THE FOLLOWING SECTIONS WILL EXPLAIN WHY.

LEGAL IMPLICATIONS

1. TESTING REQUIREMENTS: CALIFORNIA LAW REQUIRES THAT TO OPERATE A VEHICLE WITH A MANUAL TRANSMISSION, YOU MUST DEMONSTRATE PROFICIENCY IN DRIVING A MANUAL VEHICLE DURING YOUR DRIVING TEST. IF YOU PASSED YOUR DRIVING TEST IN AN AUTOMATIC VEHICLE, YOUR LICENSE IS LIMITED TO THAT TRANSMISSION TYPE.

3. INSURANCE ISSUES: DRIVING A MANUAL VEHICLE WITHOUT THE PROPER LICENSING COULD ALSO RESULT IN COMPLICATIONS WITH YOUR CAR INSURANCE. IF YOU'RE INVOLVED IN AN ACCIDENT WHILE DRIVING A MANUAL VEHICLE WITHOUT THE APPROPRIATE LICENSE, YOUR INSURANCE MAY NOT COVER DAMAGES.

HOW TO OBTAIN MANUAL DRIVING PRIVILEGES

IF YOU WISH TO DRIVE A MANUAL VEHICLE LEGALLY IN CALIFORNIA, YOU HAVE A COUPLE OF OPTIONS:

1. TAKE A MANUAL DRIVING COURSE: ENROLL IN A DRIVING SCHOOL THAT OFFERS LESSONS IN MANUAL TRANSMISSION VEHICLES. THIS WILL HELP YOU BECOME COMFORTABLE WITH OPERATING A MANUAL CAR SAFELY.

2. SCHEDULE A DRIVING TEST IN A MANUAL VEHICLE: ONCE YOU FEEL CONFIDENT IN YOUR MANUAL DRIVING SKILLS, YOU CAN SCHEDULE A DRIVING TEST WITH THE DMV USING A MANUAL TRANSMISSION VEHICLE. PASSING THIS TEST WILL ALLOW YOU TO UPGRADE YOUR LICENSE TO INCLUDE MANUAL TRANSMISSION PRIVILEGES.

BENEFITS OF LEARNING TO DRIVE MANUAL
