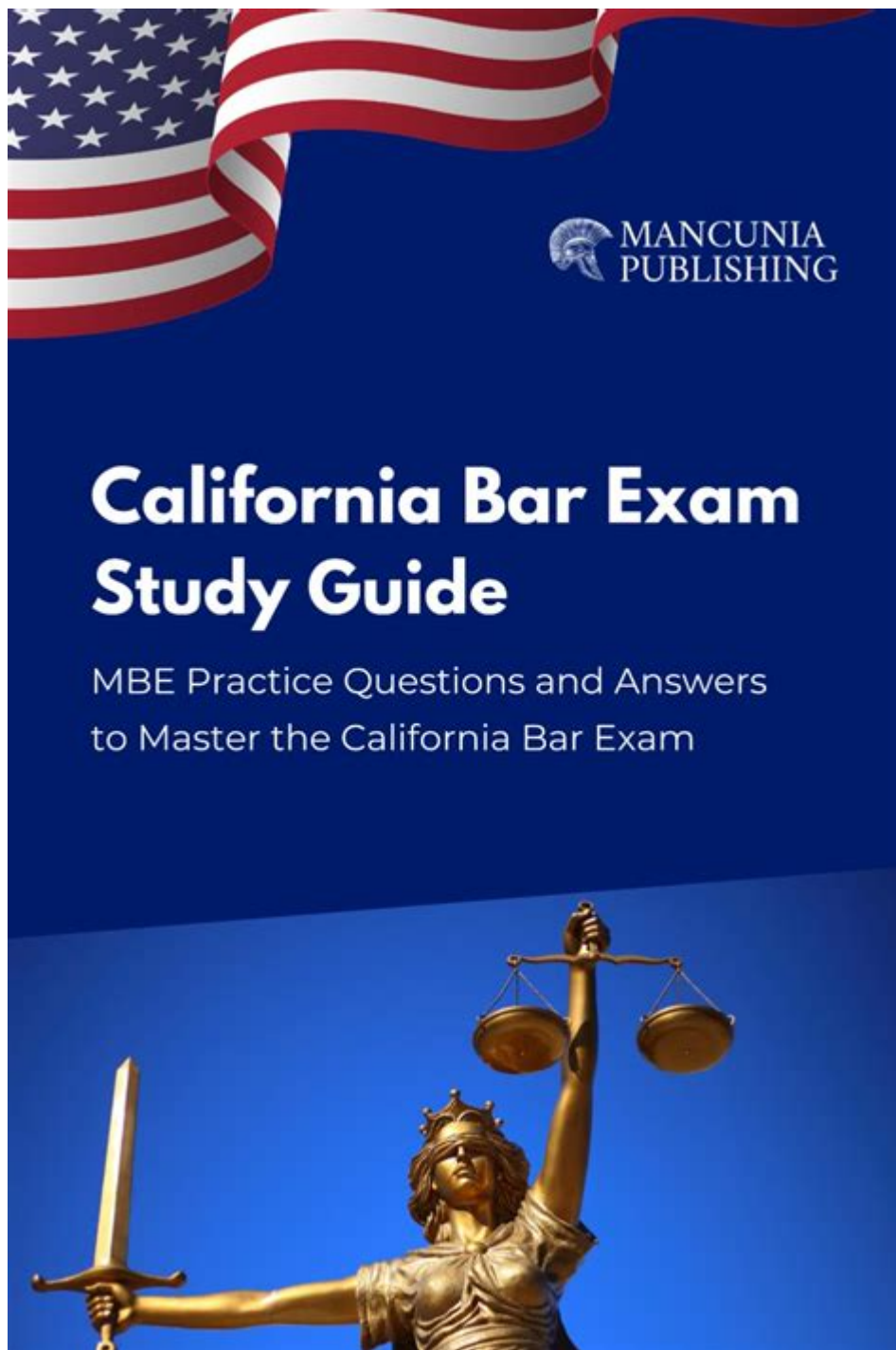


# California Bar Exam Materials
