## **TMRS Refund Application TMRS-0005**

Given the ramifications of the decision to refund your TMRS account balance, you should consult with a financial or tax advisor before you decide to do so. If you do decide to obtain a refund, you must complete the Refund Application, which requires a signature from your last employing city.

### *Refund Your Account - TMRS*

After five years, you must refund your account, and your TMRS membership will terminate. If you are vested, you can leave your contributions in your TMRS account, and they will continue to earn 5% interest each year until you retire.
