[t = \frac{\log(1.6667)}{4 \times \log(1.015)}]
[t \exp \sqrt {frac{0.2198}{4 \times 0.00647}}]
\[ t \approx \frac{0.2198}{0.02588} \]
\[ t \approx 8.50 \]
```

It will take approximately 8.5 years for the investment to reach \$2,500.
