Compound Interest

Compound interest is calculated on the **principal (original) amount** and on the **interest already accumulated** in previous periods.

$$A=P(1+\frac{r}{100})^n$$

Where:

A represents the final amount

P represents the original principal amount

r is the interest rate over a given period

n represents the number of times the interest rate is applied over time

WHERE $\backslash (A \backslash)$ IS THE AMOUNT OF MONEY ACCUMULATED AFTER N YEARS, INCLUDING INTEREST. HERE, $\backslash (N \backslash)$ IS THE NUMBER OF TIMES THAT INTEREST IS COMPOUNDED PER YEAR.
