CRUCIBLE STUDY GUIDE ACT 4

ARTHUR MILLER'S PLAY, "THE CRUCIBLE," IS A POWERFUL PORTRAYAL OF THE SALEM WITCH TRIALS, A SERIES OF HEARINGS AND PROSECUTIONS OF PEOPLE ACCUSED OF WITCHCRAFT IN COLONIAL MASSACHUSETTS. JOHN PROCTOR

- KEY QUOTE: "I COME TO DO THE DEVIL'S WORK. I COME TO COUNSEL CHRISTIANS THEY SHOULD HANG." HALE'S ADMISSION SIGNIFIES HIS DEEP REMORSE AND HIGHLIGHTS THE MORAL COMPLEXITY OF THE TRIALS.

DEPUTY GOVERNOR DANFORTH

DANFORTH EMBODIES THE RIGID AUTHORITY OF THE COURT. HE PRIORITIZES THE COURT'S REPUTATION OVER JUSTICE, LEADING TO TRAGIC OUTCOMES. HIS CHARACTER REPRESENTS THE DANGERS OF BLIND ADHERENCE TO AUTHORITY AND THE CONSEQUENCES OF PRIDE.


