SCENARIO: A PATIENT IS ADMITTED FOR A TOTAL KNEE REPLACEMENT. DURING THE SURGERY, THE SURGEON ALSO PERFORMS A PARTIAL MEDIAL MENISCECTOMY. WHICH CODES SHOULD BE REPORTED FOR THIS ENCOUNTER?

4. TRUE/FALSE QUESTIONS

THESE QUESTIONS ASSESS THE CANDIDATE'S UNDERSTANDING OF CODING GUIDELINES OR REGULATIONS. FOR EXAMPLE:

QUESTION: TRUE OR FALSE: A MODIFIER IS USED TO INDICATE THAT A SERVICE OR PROCEDURE HAS BEEN ALTERED BY A SPECIFIC CIRCUMSTANCE BUT HAS NOT CHANGED IN ITS DEFINITION OR CODE.
