WHAT KIND OF TIME AND TECHNOLOGY ARE REQUIRED?

- All you need are functioning computers, Internet access, and Adobe Flash Player 10, which is available as a free download.
- *Court Quest* takes approximately 15-30 minutes to play (depending on a student's reading speed and selection of timed or casual modes). At the end of each game session, students can print out a detailed score report that can be used for grading purposes.
- The game is best experienced in a multi-computer classroom or computer lab. Students can work individually or with partners. *Court Quest* also works as a whole-class game. It can be used with a single computer and projector, or a smartboard.
