2. SECURITY ARCHITECTURE AND TOOL SETS

THIS CATEGORY TESTS KNOWLEDGE OF SECURITY ARCHITECTURES AND SYSTEMS USED TO PROTECT ORGANIZATIONAL ASSETS. QUESTIONS MAY INCLUDE:

- UNDERSTANDING VARIOUS SECURITY FRAMEWORKS AND MODELS (E.G., NIST, ISO 27001)
- IDENTIFYING SECURITY TOOLS AND THEIR APPLICATIONS (FIREWALLS, INTRUSION DETECTION SYSTEMS, ETC.)
- ASSESSING THE EFFECTIVENESS OF SECURITY CONTROLS

SAMPLE QUESTIONS:

- WHICH OF THE FOLLOWING IS A PRIMARY FUNCTION OF AN INTRUSION DETECTION SYSTEM (IDS)?
- DESCRIBE THE DIFFERENCE BETWEEN SYMMETRIC AND ASYMMETRIC ENCRYPTION.

3. SECURITY OPERATIONS AND INCIDENT RESPONSE

QUESTIONS IN THIS DOMAIN FOCUS ON THE OPERATIONAL ASPECTS OF CYBERSECURITY, INCLUDING:

- INCIDENT RESPONSE PLANNING AND EXECUTION
- ANALYZING SECURITY EVENTS AND LOGS
- UNDERSTANDING THE INCIDENT RESPONSE LIFECYCLE

SAMPLE QUESTIONS:

- WHAT ARE THE KEY STEPS IN THE INCIDENT RESPONSE PROCESS?
- HOW WOULD YOU ANALYZE A SUSPICIOUS NETWORK LOG ENTRY?

4. GOVERNANCE, RISK, AND COMPLIANCE

- UNDERSTANDING COMPLIANCE FRAMEWORKS (E.G., GDPR, HIPAA)
- CONDUCTING RISK ASSESSMENTS AND MANAGEMENT
- DESCRIBING THE IMPORTANCE OF POLICIES AND PROCEDURES
