- Denial through compliance

In this pattern, individuals do not want to do problem-solving and they just show that they want things to go for the betterment by showing verbal compliance but their actions are totally against it.

- Manipulating Denial Pattern

In this pattern individuals want others to do problem-solving. They try to manipulate others by taking responsibility but only if other people help them to deal with it.
