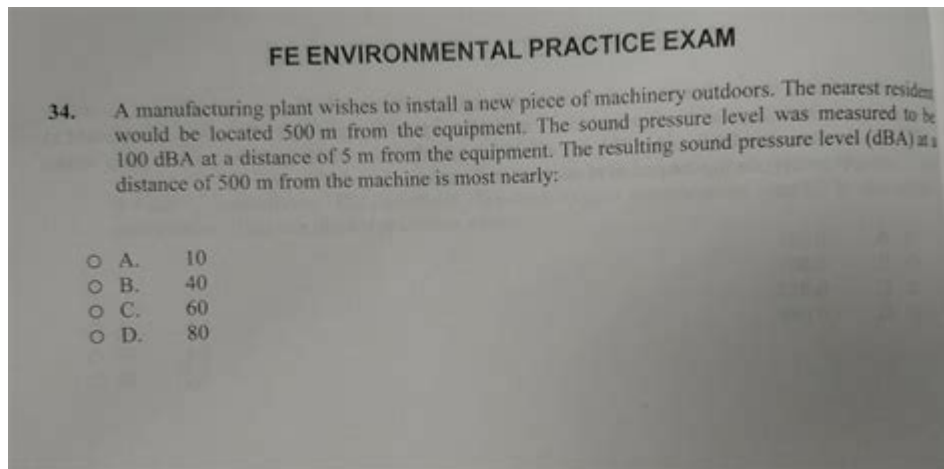


Environmental Fe Practice Exam
