- Example [k], [æ], and [t] are not meaningful in and of themselves
- Meaning emerges when sounds are combined:
 - [kæt] "cat" has one meaning (feline, the one who caught a mouse)
 - [tæk] "tack" has another (small nail)
 - [ækt] "act" has a third (dog and pony show)
- Even then, this string is language specific (English), not intrinsic
