
Example Of Concept Analysis

- 5. IDENTIFY ANTECEDENTS AND CONSEQUENCES: EXAMINE WHAT CONDITIONS MUST EXIST BEFORE THE CONCEPT CAN BE REALIZED (ANTECEDENTS) AND THE OUTCOMES THAT RESULT FROM ITS APPLICATION (CONSEQUENCES).
- 6. CONSTRUCT A MODEL CASE: CREATE AN EXAMPLE THAT CLEARLY ILLUSTRATES THE CONCEPT IN ACTION, HIGHLIGHTING ITS

ATTRIBUTES.

- 7. IDENTIFY ADDITIONAL CASES: DEVELOP CASES THAT EMBODY THE CONCEPT BUT MAY LACK SOME ATTRIBUTES, INCLUDING BORDERLINE, CONTRARY, AND RELATED CASES.
- 8. IDENTIFY IMPLICATIONS FOR PRACTICE: DISCUSS HOW THE INSIGHTS GAINED FROM THE ANALYSIS CAN INFORM PRACTICE, EDUCATION, AND RESEARCH.

EXAMPLE OF CONCEPT ANALYSIS: "EMPOWERMENT" IN NURSING

To illustrate the concept analysis process, we will explore the concept of "empowerment" within the context of nursing. Empowerment is a multifaceted concept that plays a significant role in patient care, professional practice, and health promotion.

STEP 1: SELECT A CONCEPT

STEP 6: CONSTRUCT A MODEL CASE

- RELATED CASE: A SITUATION WHERE A NURSE ADVOCATES FOR POLICY CHANGES THAT ENHANCE PATIENT RIGHTS AND ACCESS TO CARE, REFLECTING PROFESSIONAL EMPOWERMENT.

STEP 8: IDENTIFY IMPLICATIONS FOR PRACTICE

THE ANALYSIS OF EMPOWERMENT IN NURSING HAS SEVERAL IMPLICATIONS:
