What is the ICD-10-CM code for headache? - ANSWER R51

What do brackets [] indicate in the ICD-10-CM Alphabetic Index? - ANSWER Use the code(s) in brackets in addition to the disease or condition to identify an associated manifestation

What is the ICD-10-CM code for chest pain? - ANSWER R07.9

What is the ICD-10-CM code for keloid scar on the foot? - ANSWER L91.0

Refer to the Tabular List and identify the code that contains an instructional note that indicates that two related conditions cannot occur together. - ANSWER N94.2
