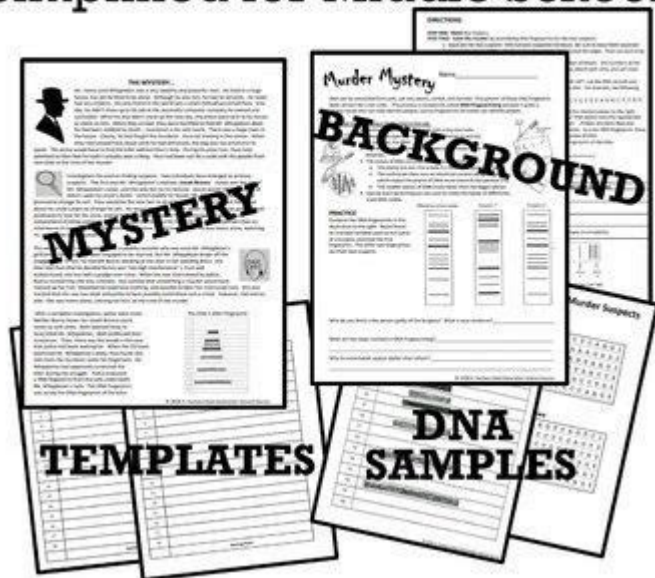


Forensic Dna Dragnet Worksheet Answers
