INSTRUCTIONS FOR FILLING OUT FORM N CEN

FILLING OUT FORM N CEN REQUIRES CAREFUL ATTENTION TO DETAIL. BELOW ARE THE STEPS AND INSTRUCTIONS TO FOLLOW WHEN COMPLETING THE FORM:

1. GATHER REQUIRED DOCUMENTATION

4. **PART 4: ADDITIONAL INFORMATION** - PROVIDE ANY ADDITIONAL INFORMATION AS REQUESTED, SUCH AS PREVIOUS APPLICATIONS OR LEGAL ISSUES.
5. **PART 5: SIGNATURE** - ENSURE THAT YOU SIGN AND DATE THE FORM. UNSIGNED FORMS WILL BE REJECTED.

3. REVIEW THE FORM

AFTER COMPLETING THE FORM, REVIEW ALL ENTRIES FOR ACCURACY. DOUBLE-CHECK FOR:

- SPELLING ERRORS
- CORRECT DATES
- PROPER FORMAT FOR ADDRESSES

HAVING A SECOND PAIR OF EYES REVIEW THE FORM CAN HELP CATCH ANY MISTAKES YOU MIGHT HAVE MISSED.

FILING INSTRUCTIONS

ONCE YOU HAVE COMPLETED AND REVIEWED FORM N CEN, THE NEXT STEP IS TO FILE IT. FOLLOW THESE INSTRUCTIONS TO ENSURE YOUR APPLICATION IS SUBMITTED CORRECTLY:

1. DETERMINE WHERE TO FILE

THE FILING LOCATION FOR FORM N CEN DEPENDS ON YOUR ELIGIBILITY CATEGORY AND WHETHER YOU ARE SUBMITTING THE APPLICATION BY MAIL OR ELECTRONICALLY. CHECK THE USCIS WEBSITE FOR THE MOST CURRENT FILING ADDRESSES AND OPTIONS.

2. PAY THE FILING FEE

A FILING FEE IS REQUIRED WHEN SUBMITTING FORM N CEN. MAKE SURE TO INCLUDE A CHECK OR MONEY ORDER MADE OUT TO "U.S. DEPARTMENT OF HOMELAND SECURITY." VERIFY THE CORRECT FEE ON THE USCIS WEBSITE, AS IT MAY CHANGE OVER TIME.

3. SUBMIT YOUR APPLICATION

YOU CAN SUBMIT YOUR APPLICATION BY MAIL OR ELECTRONICALLY, DEPENDING ON YOUR ELIGIBILITY. IF MAILING, ENSURE THAT YOU SEND IT TO THE CORRECT ADDRESS AND USE A RELIABLE MAILING SERVICE THAT PROVIDES TRACKING.

COMMON MISTAKES TO AVOID

2. PROCESSING TIME

THE PROCESSING TIME FOR FORM N CEN CAN VARY BASED ON THE WORKLOAD OF USCIS AND YOUR SPECIFIC ELIGIBILITY CATEGORY. GENERALLY, IT CAN TAKE SEVERAL WEEKS TO SEVERAL MONTHS. YOU CAN CHECK THE USCIS WEBSITE FOR CURRENT PROCESSING TIMES.

3. ADDITIONAL REQUESTS

IN SOME CASES, USCIS MAY ISSUE A REQUEST FOR EVIDENCE (RFE) IF THEY REQUIRE ADDITIONAL INFORMATION TO PROCESS YOUR APPLICATION. IT IS CRUCIAL TO RESPOND TO ANY RFEs PROMPTLY AND THOROUGHLY.
