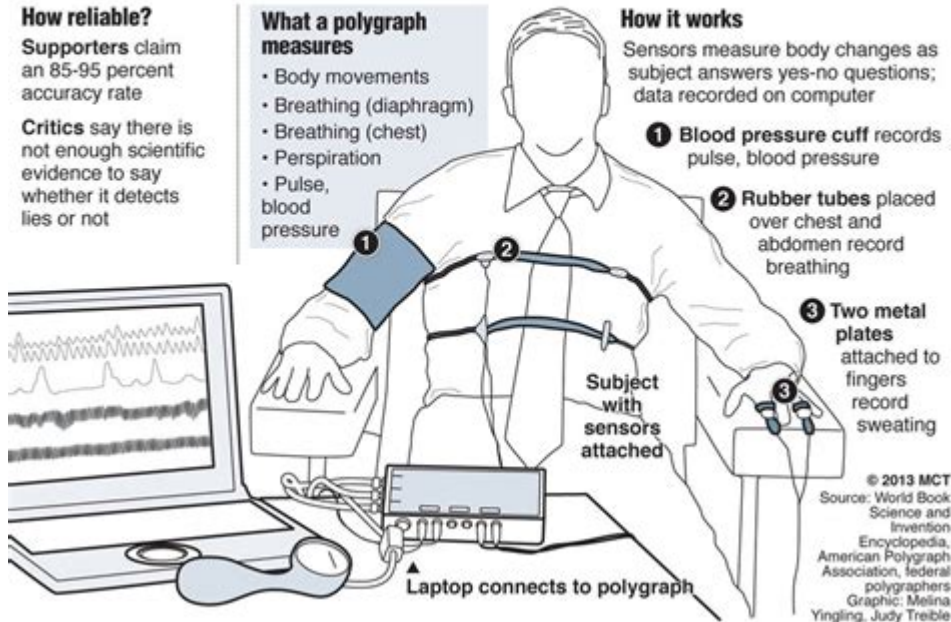
### What a polygraph measures
