1. What is the difference between direct and representative democracy?

	Direct democracy	Representative democracy
Definition	Involves continuous, uninterrupted participation of the society's citizens in the government's tasks. Hence, there is no major distinction between the state and the civil society (government and governed citizens).	Involves limited, indirect, and infrequent participation of the citizens in the government's tasks which means that citizens' role is limited to voting for their rulers every certain amount of years. Then, the rulers take decisions on the citizens' behalf it causes the relationship between the government and the governed to be reliable and effective.
Practicality	Less practical because too many opinions as there are many people taking one decision. It is practical on small scale only	More practical on a larger scale than direct democracy Less conflict in opinions
Division of labor		Those who have expertise and knowledge (most of the time) take decisions that affect the whole community whilst some others who are less experts vote on who takes these decisions.
Fairness	Catizens have more control over their destinies and are able to express their own views and since it takes the opinion of the whole society, decisions will benefit everyone	Citizens have to rely on politicians who may be in-deliberately taking decisions to benefit themselves rather than the society However, it was the citizens who chose who these politicians are
