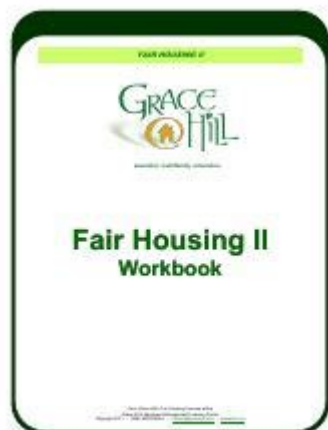


# Grace Hill Fair Housing Test Answers
