- LEARNING PROPER HANDLING TECHNIQUES
- UNDERSTANDING HOW TO LOAD, UNLOAD, AND STORE FIREARMS SAFELY
- PRACTICING CLEANING AND MAINTENANCE PROCEDURES

DEVELOPING THESE SKILLS CAN SIGNIFICANTLY ENHANCE BOTH THE CANDIDATE'S CONFIDENCE AND COMPETENCE.

### 3. REDUCING TEST ANXIETY

## 5. TAKE PRACTICE EXAMS

TAKING PRACTICE EXAMS IS ONE OF THE MOST EFFECTIVE WAYS TO PREPARE FOR THE WRITTEN PORTION OF THE TEST. THESE EXAMS CAN HELP:

- FAMILIARIZE YOURSELF WITH THE TEST FORMAT
