

1. Health History

Mr. K. was diagnosed as having an acute cerebral vascular accident. This disorder can also be described as a "stroke". It occurs when there is an interruption of normal blood flow to one or more of the blood vessels that supply the brain. Thrombosis, embolism, and hemorrhage are the primary causes of a CVA. (Summers and Johnson 2012) The causes of the brain become ischemic, leading to hypoxia or anoxia with destruction or necrosis of the neurons, glia, and vasculature. Complications of CVA include unstable blood pressure, sensory and motor impairment, infection, pneumonia, contractures, and pulmonary emboli. CVA is the third leading cause of death in the United States and affects more than 100,000 Americans annually. (Summers and Johnson 2012)
