
# **Health Information Management Technology**

- 4. PATIENT PORTALS: THESE ONLINE PLATFORMS ENABLE PATIENTS TO ACCESS THEIR HEALTH INFORMATION, COMMUNICATE WITH PROVIDERS, SCHEDULE APPOINTMENTS, AND MANAGE THEIR CARE. PATIENT PORTALS EMPOWER INDIVIDUALS TO TAKE CHARGE OF THEIR HEALTH WHILE FOSTERING BETTER COMMUNICATION BETWEEN PATIENTS AND CLINICIANS.
- 5. TELEHEALTH SOLUTIONS: WITH THE RISE OF TELEMEDICINE, HIM TECHNOLOGY NOW INCLUDES TOOLS THAT FACILITATE

REMOTE CONSULTATIONS, VIRTUAL VISITS, AND REMOTE PATIENT MONITORING. THESE SOLUTIONS HAVE BECOME ESSENTIAL, ESPECIALLY IN LIGHT OF RECENT GLOBAL HEALTH CRISES.

## THE ROLE OF HIM TECHNOLOGY IN ENHANCING PATIENT CARE

- ERROR REDUCTION: HIM TECHNOLOGY MINIMIZES ERRORS RELATED TO MEDICATION PRESCRIPTIONS, DIAGNOSTICS, AND TREATMENT PLANS THROUGH AUTOMATED ALERTS AND CLINICAL DECISION SUPPORT SYSTEMS.
- REAL-TIME MONITORING: TELEHEALTH SOLUTIONS AND REMOTE MONITORING TECHNOLOGIES ALLOW FOR TIMELY INTERVENTIONS, REDUCING THE LIKELIHOOD OF ADVERSE EVENTS.

### PATIENT ENGAGEMENT AND EMPOWERMENT

- ACCESS TO INFORMATION: PATIENT PORTALS AND MOBILE HEALTH APPLICATIONS PROVIDE PATIENTS WITH REAL-TIME ACCESS TO THEIR HEALTH DATA, FOSTERING ENGAGEMENT AND ENCOURAGING SELF-MANAGEMENT.
- EDUCATION AND SUPPORT: HIM TECHNOLOGIES OFTEN INCLUDE EDUCATIONAL RESOURCES THAT HELP PATIENTS UNDERSTAND THEIR CONDITIONS AND TREATMENT OPTIONS.

# CHALLENGES IN HEALTH INFORMATION MANAGEMENT TECHNOLOGY
