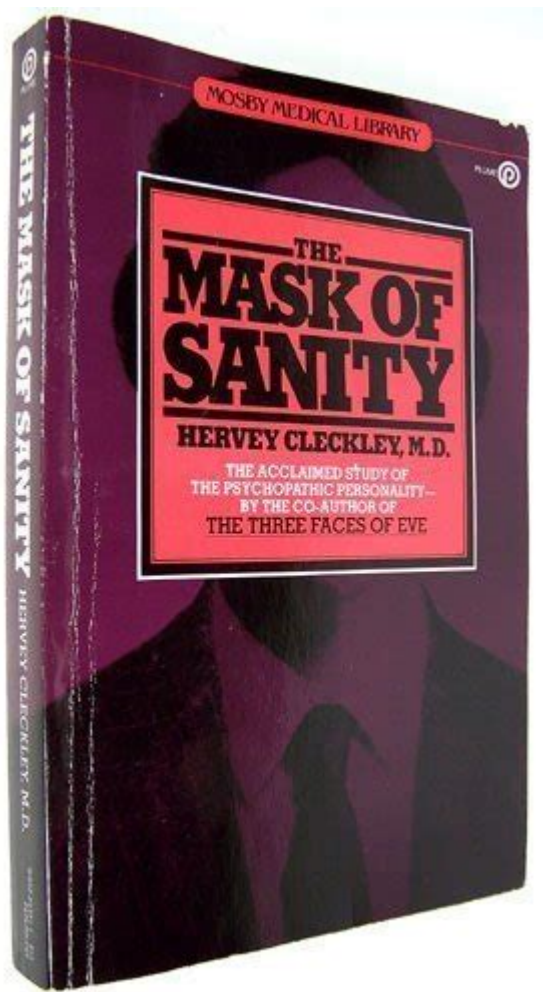


Hervey Cleckley The Mask Of Sanity



INTRODUCTION TO HERVEY CLECKLEY AND "THE MASK OF SANITY"

HERVEY CLECKLEY WAS AN INFLUENTIAL AMERICAN PSYCHIATRIST AND A PIONEER IN THE STUDY OF PSYCHOPATHY. THIS TRAIT OFTEN LEADS TO A PATTERN OF INSTABILITY IN THEIR PERSONAL AND PROFESSIONAL LIVES.

5. PARASITIC LIFESTYLE

ANOTHER SIGNIFICANT CHARACTERISTIC OF PSYCHOPATHY, AS IDENTIFIED BY CLECKLEY, IS THE TENDENCY TO LEAD A PARASITIC LIFESTYLE. PSYCHOPATHS OFTEN EXPLOIT OTHERS FOR FINANCIAL GAIN OR EMOTIONAL SUPPORT, RELYING ON MANIPULATION AND DECEIT TO MAINTAIN THEIR LIVELIHOODS.
