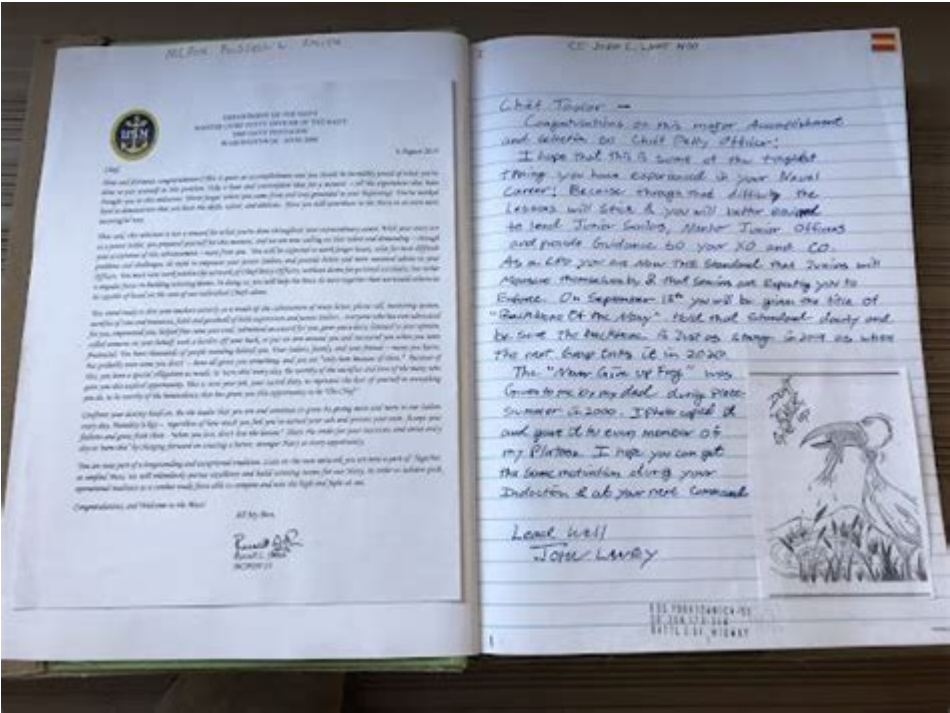


History Of The Charge Book
