
# How Do I Remove My Business From Yelp

# UNDERSTANDING YELP'S BUSINESS LISTING

# WHY WOULD YOU WANT TO REMOVE YOUR LISTING?

THERE ARE SEVERAL REASONS A BUSINESS OWNER MIGHT CONSIDER REMOVING THEIR YELP LISTING:

- NEGATIVE REVIEWS: IF YOUR BUSINESS HAS RECEIVED NUMEROUS NEGATIVE REVIEWS THAT YOU BELIEVE MISREPRESENT YOUR SERVICES.
- CLOSURE OF BUSINESS: IF YOUR BUSINESS HAS CLOSED DOWN, IT MAY BE APPROPRIATE TO REMOVE THE LISTING.
- REBRANDING: IF YOU HAVE CHANGED YOUR BUSINESS NAME OR MOVED TO A NEW LOCATION, YOU MAY WANT TO REMOVE THE OLD LISTING.
- Lack of Engagement: If you find that Yelp does not contribute to your business growth or customer engagement.

# STEPS TO REMOVE YOUR BUSINESS FROM YELP

REMOVING YOUR BUSINESS FROM YELP IS A STRAIGHTFORWARD PROCESS, BUT IT REQUIRES YOU TO FOLLOW SPECIFIC STEPS TO ENSURE THAT YOUR REQUEST IS HANDLED CORRECTLY.

# STEP 1: CLAIM YOUR BUSINESS LISTING

Before you can remove your business from Yelp, you must claim the listing. If you haven't claimed your business yet, follow these steps:

- 1. GO TO THE YELP FOR BUSINESS PAGE.
- 2. SEARCH FOR YOUR BUSINESS USING THE SEARCH BAR.

IF YOUR BUSINESS IS NOT LISTED, YOU CAN CREATE A NEW LISTING INSTEAD.

### STEP 2: ACCESS YOUR BUSINESS ACCOUNT

Once you've claimed your business, log in to your Yelp for Business account. Here, you will have access to various management features, including the ability to update or remove your business listing.

# STEP 3: REQUEST TO REMOVE YOUR BUSINESS LISTING

Now that you're logged into your account, you'll need to navigate to the option for removing your business. Follow these steps:

- 1. Go to the Business Information Tab: In your account dashboard, find the section that deals with your business information.
- 2. Look for Remove Listing Option: Scroll down to find the option that says something like "Remove Listing" or "Close Business."
- 3. Submit Your Request: Click on the option and follow the prompts. You may be asked to provide a reason for the removal.

# STEP 4: CONFIRM YOUR REQUEST

AFTER SUBMITTING YOUR REQUEST, YOU MAY RECEIVE A CONFIRMATION EMAIL OR NOTIFICATION FROM YELP. THIS MAY INCLUDE ADDITIONAL INSTRUCTIONS OR A TIMEFRAME FOR WHEN YOUR LISTING WILL BE REMOVED.

# WHAT HAPPENS AFTER YOU REMOVE YOUR LISTING?

Once you've successfully requested the removal of your business from Yelp, there are several things to keep in mind:

- TIMEFRAME FOR REMOVAL: YELP GENERALLY PROCESSES REMOVAL REQUESTS WITHIN A FEW DAYS, BUT IT MAY TAKE LONGER DEPENDING ON THEIR WORKLOAD.
- REVIEWS AND RATINGS: ALL REVIEWS AND RATINGS ASSOCIATED WITH YOUR BUSINESS WILL ALSO BE REMOVED ONCE YOUR LISTING IS TAKEN DOWN.
- REOPENING YOUR BUSINESS: IF YOU DECIDE TO REOPEN YOUR BUSINESS IN THE FUTURE, YOU WILL NEED TO CREATE A NEW LISTING.

# ALTERNATIVE OPTIONS TO CONSIDER

IF REMOVING YOUR BUSINESS FROM YELP SEEMS TOO DRASTIC, CONSIDER THESE ALTERNATIVES:

#### RESPONDING TO REVIEWS

INSTEAD OF REMOVING YOUR BUSINESS, YOU CAN ACTIVELY MANAGE YOUR LISTING BY:

- RESPONDING TO NEGATIVE REVIEWS PROFESSIONALLY.
- ENCOURAGING SATISFIED CUSTOMERS TO LEAVE POSITIVE REVIEWS.
- UPDATING YOUR BUSINESS INFORMATION TO REFLECT CHANGES OR IMPROVEMENTS.

#### UPDATING BUSINESS INFORMATION

IF YOUR BUSINESS HAS CHANGED, CONSIDER UPDATING YOUR LISTING INSTEAD OF REMOVING IT. YOU CAN:

- CHANGE YOUR BUSINESS NAME.
- UPDATE YOUR ADDRESS OR PHONE NUMBER.
- Modify your hours of operation.

# HIDING YOUR BUSINESS FROM PUBLIC VIEW

YELP ALSO OFFERS AN OPTION TO HIDE YOUR BUSINESS LISTING FROM PUBLIC VIEW. THIS IS A TEMPORARY SOLUTION THAT ALLOWS YOU TO TAKE A BREAK FROM YELP WITHOUT PERMANENTLY REMOVING YOUR LISTING. TO DO THIS:

- 1. LOG IN TO YOUR YELP FOR BUSINESS ACCOUNT.
- 2. NAVIGATE TO THE SETTINGS OR BUSINESS INFORMATION SECTION.
- 3. LOOK FOR THE OPTION TO HIDE YOUR BUSINESS LISTING.

# CONCLUSION

## HOW DO I REMOVE MY BUSINESS LISTING FROM YELP?

To remove your business listing from Yelp, you need to claim the business first. Once claimed, you can go to the 'Business Information' section and select 'Remove Listing' to start the process.

# CAN I DELETE MY YELP BUSINESS ACCOUNT COMPLETELY?

IF YOU REMOVE YOUR BUSINESS FROM YELP, ALL REVIEWS ASSOCIATED WITH THAT BUSINESS WILL ALSO BE REMOVED, AND USERS WILL NO LONGER BE ABLE TO FIND YOUR BUSINESS'S PAGE.

### IS IT POSSIBLE TO DEACTIVATE MY YELP BUSINESS LISTING INSTEAD OF REMOVING IT?

YES, YOU CAN DEACTIVATE YOUR YELP BUSINESS LISTING IF YOU PREFER NOT TO REMOVE IT COMPLETELY. THIS OPTION IS AVAILABLE IN THE 'BUSINESS INFORMATION' SECTION AFTER CLAIMING YOUR LISTING.

# WILL REMOVING MY BUSINESS FROM YELP AFFECT MY ONLINE PRESENCE?

REMOVING YOUR BUSINESS FROM YELP CAN AFFECT YOUR ONLINE PRESENCE SINCE YELP IS A POPULAR PLATFORM FOR REVIEWS AND LOCAL SEARCHES. IT MIGHT REDUCE VISIBILITY TO POTENTIAL CUSTOMERS.

### HOW LONG DOES IT TAKE FOR MY YELP LISTING TO BE REMOVED?

## WHAT IF I WANT TO KEEP MY REVIEWS BUT REMOVE MY BUSINESS FROM YELP?

IF YOU WANT TO KEEP YOUR REVIEWS, YOU CANNOT REMOVE YOUR BUSINESS FROM YELP. THE REVIEWS ARE TIED TO THE BUSINESS LISTING, AND REMOVING THE LISTING WILL ALSO REMOVE THE REVIEWS.

# ARE THERE ANY FEES ASSOCIATED WITH REMOVING MY BUSINESS FROM YELP?

NO. THERE ARE NO FEES TO REMOVE YOUR BUSINESS FROM YELP, THE PROCESS IS FREE ONCE YOU HAVE CLAIMED YOUR BUSINESS.

## HOW CAN I CONTACT YELP SUPPORT FOR HELP WITH REMOVAL?

YOU CAN CONTACT YELP SUPPORT THROUGH THEIR HELP CENTER. THEY PROVIDE OPTIONS FOR SUBMITTING INQUIRIES, INCLUDING REQUESTS FOR BUSINESS LISTING REMOVAL.
