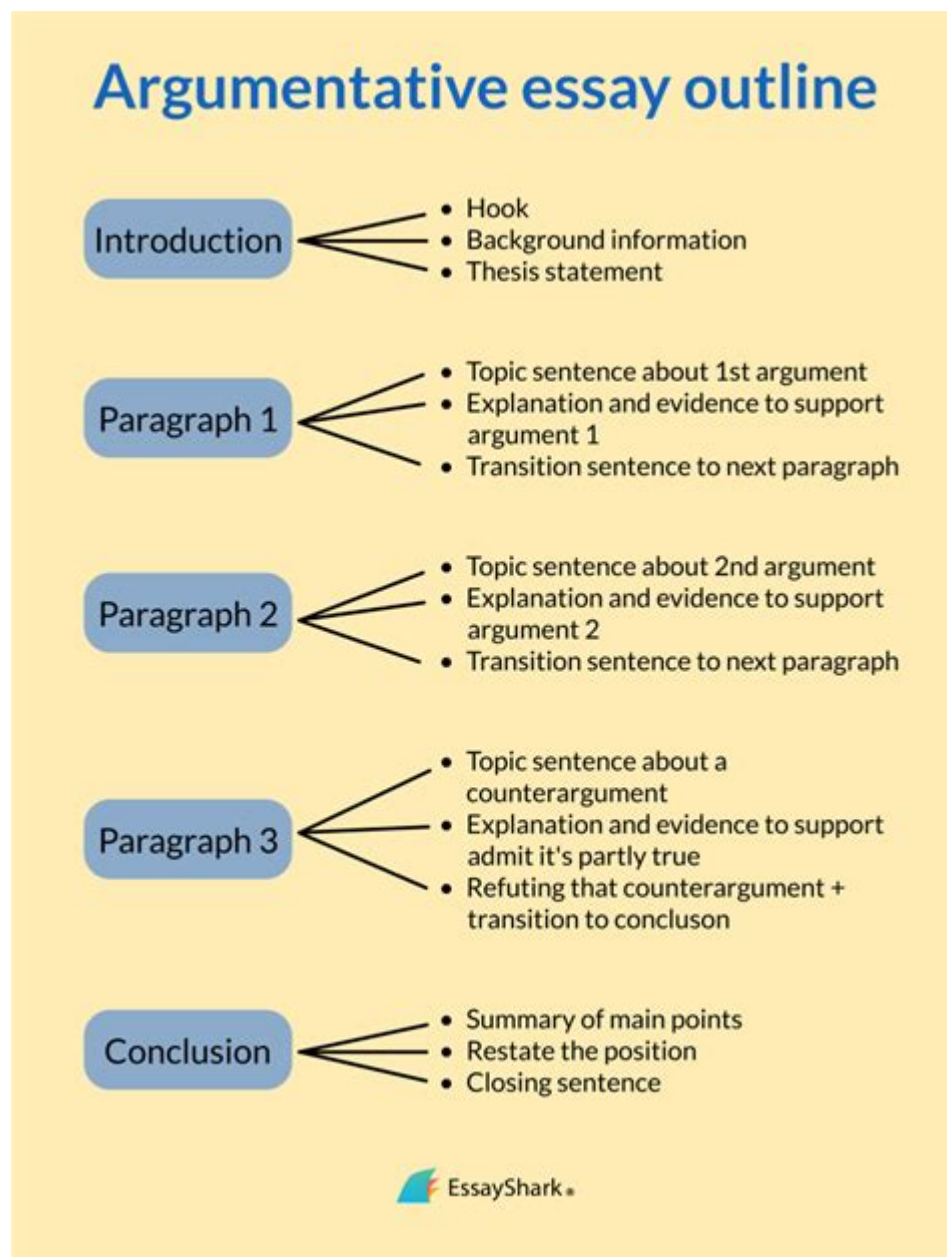


# How To Write An Argumentative Essay
