Preventive control ----- **Correct Answer** ----- helps prevent the entry and spread of pests  
-quarantines, inspections, certified seed, cleaning equipment, controlling before seed production, nutrient control

chemical control ----- **Correct Answer** ----- Use of pesticides or herbicides to manage an unwanted organism(s)  
-herbicides, insecticides, fungicides, repellents, fumigants

pests ----- **Correct Answer** ----- insects and other animals, weeds, and diseases that may negatively impact a human goal
