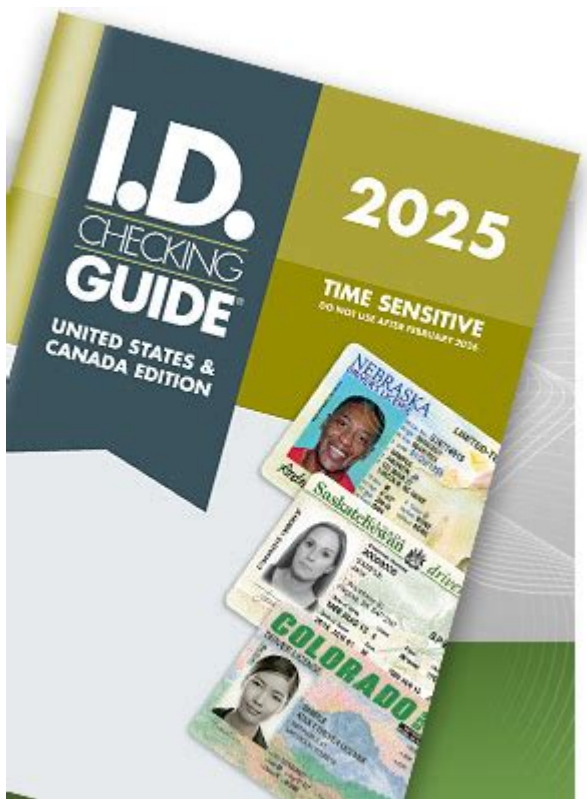


Id Checking Guide

METHODS FOR ID CHECKING

2. ID SCANNING TECHNOLOGY
