UNDERSTANDING ICS 200

COURSE OBJECTIVES

ICS 200 TEST OVERVIEW

- ANSWER: SPAN OF CONTROL REFERS TO THE NUMBER OF SUBORDINATES THAT A SUPERVISOR CAN EFFECTIVELY MANAGE. IN ICS, IT IS TYPICALLY RECOMMENDED THAT ONE SUPERVISOR MANAGE NO MORE THAN 3 TO 7 PERSONNEL.
5. QUESTION: WHY IS COMMUNICATION CRITICAL DURING AN INCIDENT?
- ANSWER: EFFECTIVE COMMUNICATION ENSURES THAT ALL RESPONDERS ARE AWARE OF THEIR ROLES, RESPONSIBILITIES, AND THE OVERALL INCIDENT OBJECTIVES, THEREBY ENHANCING COORDINATION AND REDUCING THE LIKELIHOOD OF ERRORS.
