

A DEMAND SCHEDULE IS A TABLE THAT SHOWS THE QUANTITY OF A GOOD THAT CONSUMERS ARE WILLING TO BUY AT DIFFERENT PRICE LEVELS.

WHAT IS A DEMAND CURVE?

A DEMAND CURVE IS A GRAPHICAL REPRESENTATION OF THE RELATIONSHIP BETWEEN THE PRICE OF A GOOD AND THE QUANTITY DEMANDED, TYPICALLY SLOPING DOWNWARDS FROM LEFT TO RIGHT.

WHAT ROLE DO SUBSTITUTES PLAY IN DEMAND?

SUBSTITUTES ARE GOODS THAT CAN REPLACE EACH OTHER; WHEN THE PRICE OF ONE SUBSTITUTE RISES, THE DEMAND FOR THE OTHER TYPICALLY INCREASES AS CONSUMERS SWITCH TO THE CHEAPER OPTION.

WHAT IS THE CONCEPT OF ELASTICITY OF DEMAND?

ELASTICITY OF DEMAND MEASURES HOW RESPONSIVE THE QUANTITY DEMANDED OF A GOOD IS TO A CHANGE IN ITS PRICE; IT CAN INDICATE WHETHER DEMAND IS ELASTIC (SENSITIVE TO PRICE CHANGES) OR INELASTIC (LESS SENSITIVE).

HOW DO CONSUMER EXPECTATIONS AFFECT DEMAND?

IF CONSUMERS EXPECT PRICES TO RISE IN THE FUTURE, THEY MAY INCREASE THEIR CURRENT DEMAND; CONVERSELY, IF THEY EXPECT PRICES TO FALL, THEY MAY HOLD OFF ON PURCHASES, REDUCING CURRENT DEMAND.
