Expected Utility Theory

1. On p.100 Jehle and Reny say that AXIOM G4 (Monotonicity) implies $a_i \succ a_e$. Prove this.

Answer

We prove this by contradiction. Suppose $a_1 \sim a_n$, then $a_1 \geqslant a_n$ and $a_n \geqslant a_1$.

Furthermore, suppose we take $\alpha > \beta$.

Then by MON $(\alpha \circ a_1, (1-\alpha) \circ a_n) \geqslant (\beta \circ a_1, (1-\beta) \circ a_n)$ but also

 $(\alpha \circ a_n, (1-\alpha) \circ a_i) \Rightarrow (\beta \circ a_n, (1-\beta) \circ a_i).$

The latter can be rearranged $((1-\alpha) \circ a_1, \alpha \circ a_n) \Rightarrow ((1-\beta) \circ a_1, \beta \circ a_n)$ which by MON implies $1-\alpha \ge 1-\beta$ which implies $\beta \ge \alpha$ which contradicts the assumption.

Which of the following utility functions have the DARA property, that is, the Arrow-Pratt measure of absolute risk aversion R_a is decreasing in wealth.

- (i) $u(w) = \ln w$
- (ii) $u(w) = -a(w^2 2bw)$; a, b > 0
- (iii) $u(w) = 1 e^{1-u}$
- (iv) $u(w) = aw^{\alpha}$; $\alpha > 0, \alpha > 0$
- (v) Discuss why or why not DARA is a convincing property.
