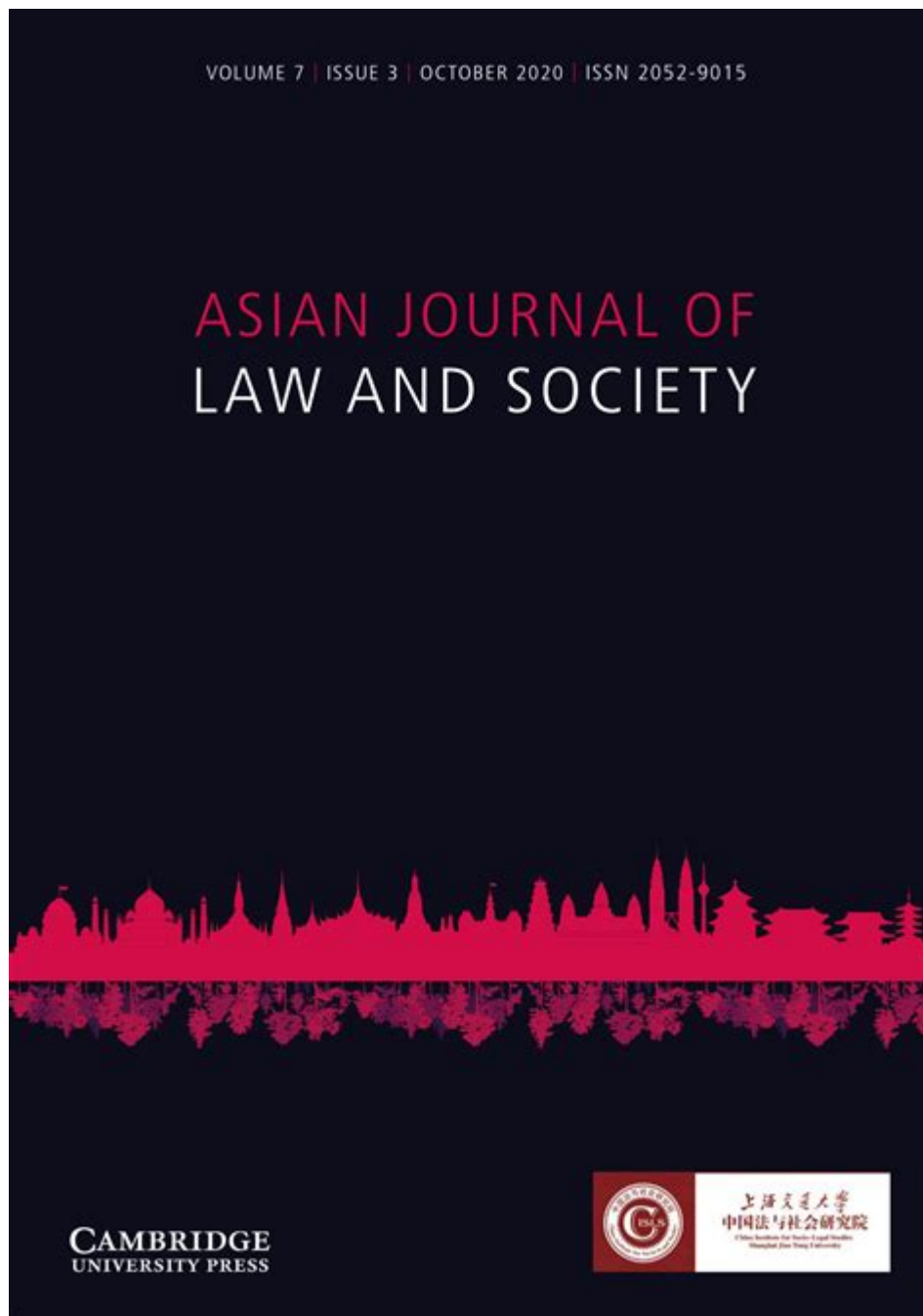


# Journal Of Law And Society
