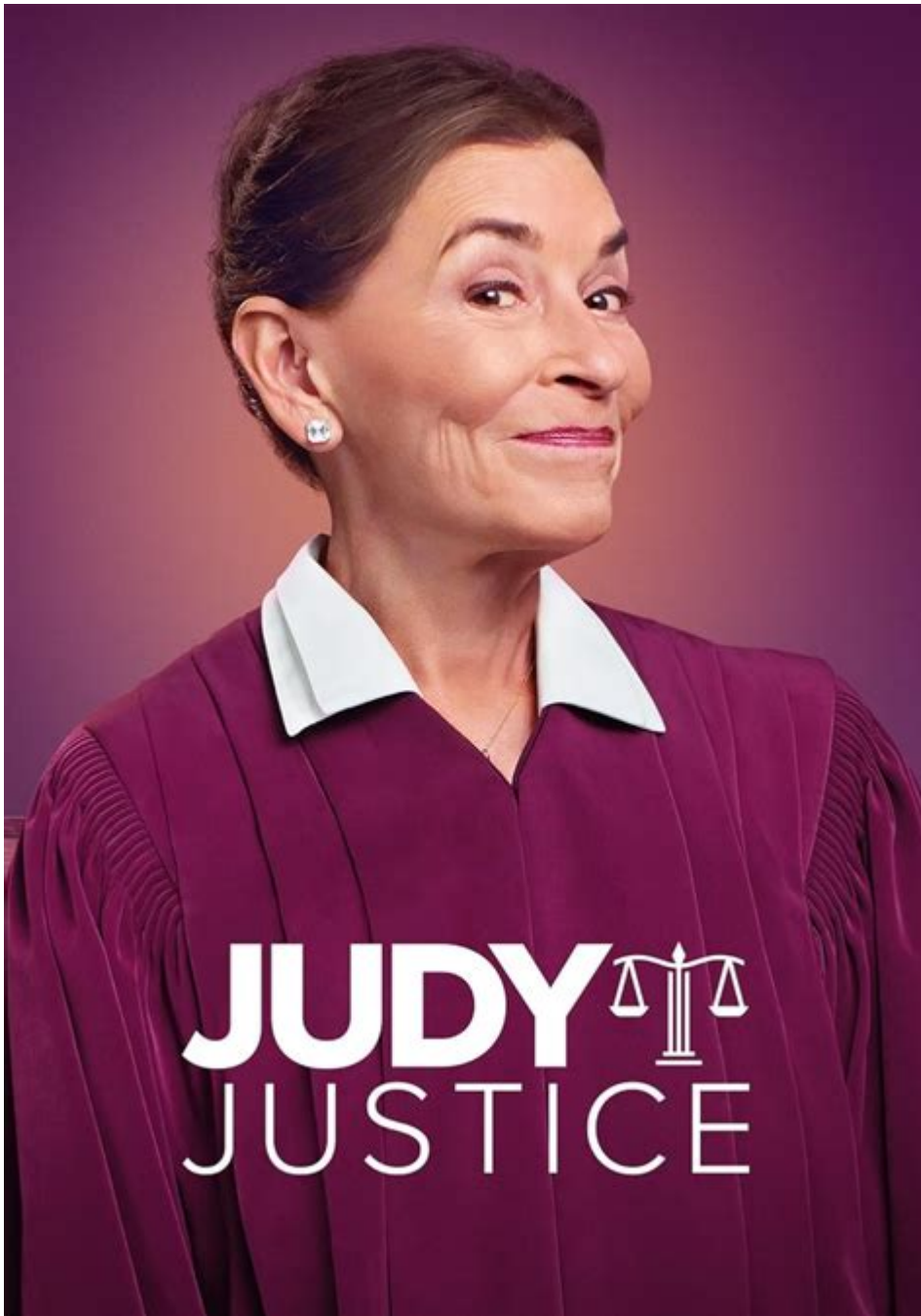


Judy Justice Episode Guide
