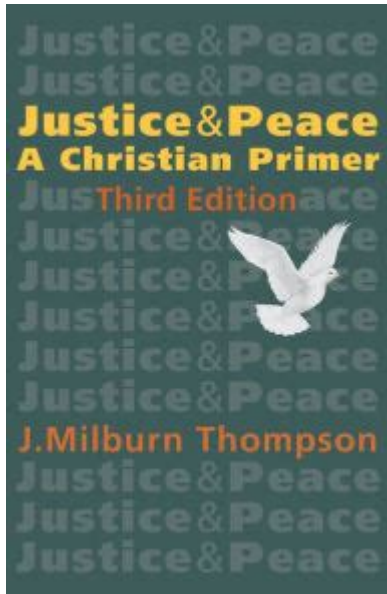


# Justice And Peace A Christian Primer Second Edition

2. VOLUNTEER: GET INVOLVED IN LOCAL CHARITIES, SHELTERS, OR JUSTICE ORGANIZATIONS.
3. SUPPORT FAIR TRADE: PURCHASE PRODUCTS THAT ENSURE FAIR WAGES AND WORKING CONDITIONS FOR WORKERS GLOBALLY.

## COMMUNITY ACTIONS

1. HOST DISCUSSIONS: CREATE SPACES FOR DIALOGUE WITHIN YOUR CHURCH OR COMMUNITY TO DISCUSS JUSTICE AND PEACE ISSUES.
2. ORGANIZE EVENTS: PLAN EVENTS THAT RAISE AWARENESS, SUCH AS FILM SCREENINGS, SPEAKER SERIES, OR COMMUNITY SERVICE DAYS.
3. ADVOCATE FOR POLICY CHANGE: ENGAGE WITH LOCAL LEADERS TO PROMOTE POLICIES THAT ENHANCE JUSTICE AND PROTECT THE VULNERABLE.
