

Level 1 Med Aide Training

TRAINING REQUIREMENTS

TO ENROLL IN LEVEL 1 MED AIDE TRAINING, CANDIDATES TYPICALLY NEED TO MEET SPECIFIC PREREQUISITES, WHICH MAY INCLUDE:

- A HIGH SCHOOL DIPLOMA OR GED EQUIVALENT
- COMPLETION OF A BACKGROUND CHECK
- BASIC HEALTHCARE KNOWLEDGE OR EXPERIENCE (PREFERRED BUT NOT ALWAYS REQUIRED)
