OVERVIEW OF THE PROGRAM

PROGRAM STRUCTURE

THIS PRACTICAL EXPERIENCE IS VITAL FOR DEVELOPING THE SKILLS NECESSARY TO SUCCEED AS A THERAPIST.

FACULTY AND RESOURCES

- Nonprofit Organizations: Engaging in advocacy and providing support services to families facing various challenges.

JOB MARKET OUTLOOK

The demand for marriage and family therapists is expected to grow significantly in the coming years due to increasing awareness of mental health issues and the importance of family dynamics. The U.S. Bureau of Labor Statistics (BLS) projects that employment for marriage and family therapists will grow by 22% from 2021 to 2031, which is much faster than the average for all occupations.
