


# Lifeguard Management Manual American Red Cross

## KEY COMPONENTS OF THE LIFEGUARD MANAGEMENT MANUAL

AN EFFECTIVE EMERGENCY ACTION PLAN (EAP) IS CRITICAL FOR RESPONDING TO EMERGENCIES. THE MANUAL EMPHASIZES:

- DEVELOPMENT OF EAPS: EACH FACILITY SHOULD HAVE A TAILORED EAP THAT OUTLINES SPECIFIC PROCEDURES FOR VARIOUS EMERGENCIES (E.G., DROWNING, SEVERE WEATHER).

- STAFF ORIENTATION: NEW LIFEGUARDS SHOULD RECEIVE COMPREHENSIVE ORIENTATION ON THE MANUAL'S CONTENTS, EMPHASIZING THE IMPORTANCE OF ADHERENCE TO PROTOCOLS.
- CONTINUOUS EDUCATION: ENCOURAGE ONGOING EDUCATION FOR ALL STAFF TO STAY UPDATED ON BEST PRACTICES AND NEW DEVELOPMENTS IN LIFEGUARDING.

### 2. REGULAR REVIEW AND UPDATES

- MANUAL REVIEW: REGULARLY REVIEW THE MANUAL TO IDENTIFY AREAS FOR IMPROVEMENT BASED ON FEEDBACK FROM STAFF AND INCIDENT REPORTS.
