Duty to act \_\_\_\_ - A legal responsibility to respond to an emergency while on the job.

Standard of care - The benchmark by which the actions of a caregiver with similar training and experience is measured.

Negligence \_\_\_\_ - A failure to act or to use reasonable care that results in injury or that causes further harm.

Good Samaritan laws \_\_\_\_ - Statutes that generally provide legal protection to people who willingly (without a duty to act) give emergency care without being negligent or accepting anything in return

Consent \_\_\_\_ - Permission to provide care given by an injured adult or the parent of an injured child to a rescuer or caregiver. This permission is implied when the adult is unresponsive or the child is unattended.

Refusal of care \_\_\_\_ - An unwillingness to receive first aid or medical treatment expressed by a victim (or the victim's parent or guardian) who must give consent.

Abandonment \_\_\_\_ - The failure to continue care once it has been initiated.
